1. If a payment is due on the other bank's credit card or charge account within the next 10 business days from the date you posted this application, please make this payment. The Warehouse Financial Services accepts no liability for late payments, or any other payments arising from your closing of your other bank's credit card.
2. Your The Warehouse credit card must remain within its credit limit. The Warehouse Financial Services credit card standard terms of use apply.
3. The balance transfer is subject to The Warehouse Financial Services approval. The Warehouse Financial Services has the right to refuse any transfers.
4. Balances may be transferred from New Zealand issued Visa, MasterCard, Amercian Express (Centrion Finance) and Diners Club cards.
5. Balances may also be transferred from another banks personal loan or overdraft, Farmers Card, GE Creditline Card, other store cards, and any hire purchase agreement. You cannot transfer a balance from a The Warehouse Financial Services Card. You are responsible for any residual interest charges or late transactions.
6. The Warehouse Financial Services will only transfer the debit balance as shown on this form.
7. Interest will be charged on a daily basis from the date we transfer your balance.
8. Payments made to your card account will be applied against balance transfers before all cash advances and other purchases, but after all charges and interest that has been accrued.
9. Should your balance transfer be for a fixed period of time as part of a promotion (for example, six months), any outstanding balance at the end of the promotional period will be charged at the purchases interest rate.
10. The information provided will be held by The Warehouse Financial Services and will be used now and in the future to make available to you other services offered by The Warehouse Financial Services. You have the right to access and correct this information as subject to the provisions of the Privacy Act 1993.
11. There is a maximum of two balance transfers per year to your The Warehouse MasterCard.
12. Please allow 10 days from our receipt of the balance transfer request for processing.
